The Assembly roll was called and the Credentials Report was read. 18 representatives and 5 Steering Committee members were present, for a total of 23 votes. It was moved and seconded that the Credentials Report be accepted. The Credentials Report was accepted.

The minutes from the Fall 2015 Assembly were presented and approved as presented.

The Recording Secretary moved to adopt the proposed Assembly Standing Rules; seconded. The proposed Standing Rules were adopted as presented.

The Recording Secretary moved to adopt the proposed Agenda for the Assembly, with adjustments to be made as necessary; seconded. The proposed Agenda was adopted as presented.

The Parliamentarian gave a five-minute presentation about parliamentary procedure and the purpose of Bylaws (who we are) and Policy Manual (what we do). She also announced that this will be her last Assembly with us due to rotation of service.

The Representatives and Steering Committee introduced themselves by coming to the front of the Assembly, each giving their name, stating the service body they represent, and voicing a gratitude for the day.

Steering Committee Reports:

She encouraged representatives to double check their local donation information. The Treasurer began circulating the 7th Tradition envelope.

Recording Secretary: In addition to her written report, Kay S. gave details regarding the blue folder being circulated for updated contact information and explained how that contact information is used.

Communications Secretary: In addition to her written report, Christina S. spoke about the process for maintaining the technology needs and updates for the region.

Trustee: In addition to her written report, Vicki W. spoke about staff changes at WSO, with a new Managing Director and Controller. She also spoke about writing for *Lifeline* and encouraged subscriptions. She provided updated contact information: phone 435-610-2595 and email vtwilcox@gmail.com. Vicki explained and began circulating the envelope for the *Lifeline* drawing.

A ten-minute break was called at 9:12 a.m. The Assembly reconvened at 9:32 a.m. and an updated Credentials Report was established. No changes; 18 representatives and 5 Steering Committee members were present, for a total of 23 votes.

The Assembly was given two additional minutes to review the Consent Agenda material. Consent Agenda was adopted as revised.

Policy Manual amendment motion 5 was presented. Motion carried.

Policy Manual amendment motion 6 was presented. Motion carried.

Policy Manual amendment motion 8 was presented. Motion withdrawn.

Policy Manual amendment motion 9 was presented. Motion withdrawn.

A fifteen-minute break was called at 10:35 a.m. The Assembly reconvened at 11:02 a.m.

Committees:

The Chair announced the Mid-Term conference call for all Steering Committee members and committee chairs will be on Monday, July 18, 2016 at 7:00 p.m. Eastern / 6:00 p.m. Central / 5:00 p.m. Mountain / 4:00 p.m. Pacific.

The Chair determined that two committees will not meet this Assembly due to lack of relevant business: Unity with Diversity and Communications/Technology. The Assembly broke into four committee groups to work independently over the lunch break. The committee chairs returned at 1:45 p.m. and the Assembly reconvened at 2:00 p.m. to hear the committees' reports.

The Lifeline Drawing collected enough for two paper subscriptions and two e-subscriptions. Julie from Utah and Christina from ASDI. Kay from DMI won both e-Lifeline subscriptions and converted them to a paper copy. Winners will provide name, address, email, and phone for the subscriptions to Treasurer.

Summary of Friday Forum presented by Vice Chair. Discussed the practice of unity in the fellowship and reducing "us vs. them" thinking.
